

INSTALLATION TIPS	OPERATION TIPS	SIZING
Never use a saddle valve for connection.	Change cartridges on a regular six (6) month preventative maintenance program.	
Use 3/8" water line. Install vertically with cartridge hanging down.	Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).	
Allow 2-1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.	Always flush the filter cartridge at time of installation and cartridge change.	
Flush 2SR-BW Cartridge by running water through filter for three (3) minutes at full flow.
